



2. **Ms. KATTARI HARIKA**, D/o of Kattari Srinivasa Kiran Raju aged 24 years, residing H. No. 3-16B-102/1, Santhi Nagar, Kakinada, East Godavari, Andhra Pradesh-533003, hereinafter referred to as the 'Party of the **SECOND PART**'.

- c) The interest shall be credited to the accounts of the partners and shall be treated as further contribution of capital and shall be eligible for interest at the above rate in the subsequent year and so on.
- d) The Net Profit or Losses (including Capital gains derived or Losses sustained if any) of the partnership shall be distributed among the partners in the following manner.

5. The accounts of the partnership shall be maintained in the manner usual for a similar profession and they shall be first closed to profit and loss account on 31st March every year and the accounts may be looked into by all the partners at any time during the business.
6. The divisible profits or losses shall be arrived at after providing for interest on capital of the partner and salary, bonus, commission or remuneration payable to the partners as hereinafter mentioned along with other business expenditure.
7. The First partner Mr. DASARI ADITYA shall be the Partner and Second partner Ms. KATTARI HARIKA shall be partner and they shall be equally responsible for the day to day functioning of the business, purchase of Materials & Machinery, and maintenance of books of accounts and appointment of required staff or any other relevant matter connected herewith.
8. The bank account or accounts shall be opened in the name of the firm and such account or accounts shall be operated by either jointly or severally by passing the resolution duly signed by First party and Second Party.
9. The parties of the First and Second parts are authorized jointly to borrow funds by pledge or by hypothecation of the partnership assets for the purpose of partnership business from banks and financial Institutions (Govt./semi Government) and private bodies including individuals to such extent and at such rate of interest as they deem fit from time to time and in connection thereon, the said partners shall also have the powers to :
- Mortgage, pledge or hypothecate the assets of the partnership business;
 - Stand indemnity or give personal guarantee on behalf of the firm to the lenders;

Otherwise secure the borrowing by offering collateral security to meet the borrowing stipulations of the lender.

10. The death, retirement or the insolvency of any partner or partners shall not dissolve the firm. In the event of the death of a partner, his nominee may be taken in as partner or admitted to the benefits of partnership if agreed to by the surviving partners.

12. The name and style, place of business and goodwill of the partnership or any shall always belongs to the continuing partners.
13. For the purpose of the above calculation the book profits shall be computed as defined in explanation 3 of Section 40 (b)(v) of the Income Tax Act, 1961 or any other applicable provisions as may be in force for the Income Tax Assessment of Partnership Firms and the remuneration shall be credited to the account of the above partners as on the last day of the accounting period.
14. The above annual remuneration payable to the above partner shall be calculated at the time of finalization of the accounts of the partnership and shall be credited to the account of the above partners as on the last day of the accounting period.
15. The partners by mutual consent shall be entitled to increase or reduce the above remuneration and it shall be within the limits as mentioned in the Income Tax Act, 1961 from time to time.
16. The partners may create any reserves to meet any unforeseen future contingencies or liabilities the quantum of which shall be decided by the partners from time to time.
17. The firm can draw relevant rules and resolutions, terms and conditions, prospectus for the purpose of acceptance of deposits or loans, grant of advance etc.
18. In case of any dispute among the partners the same may be referred to the arbitrators as decided by the partners.
19. In matters not touched by these presents, the provisions of the Indian Partnership Act, 1932 shall apply.
